If this proposition is approved, the adjusted debt service levy of the District is expected to remain unchanged at the current levy of \$0.7761 per one hundred dollars assessed valuation of real and personal property.

All of the area currently being served by the Halfway Volunteer Fire Department, and specifically:

BEGINNING ON THE WEST LINE OF SECTION 17, TOWNSHIP 34 NORTH, RANGE 22 WEST OF THE FIFTH PRINCIPAL MERIDIAN IN POLK COUNTY, MISSOURI AT THE POMME DE TERRE RIVER, THENCE SOUTHERLY ALONG SAID RIVER TO THE INTERSECTION OF SAID RIVER AND THE SOUTH LINE OF THE NORTH HALF OF SECTION 36, TOWNSHIP 33 NORTH, RANGE 22 WEST, THENCE EAST ALONG SAID SOUTH LINE TO THE SOUTHEAST CORNER OF SAID NORTH HALF OF SECTION 36, THENCE NORTH ALONG THE EAST LINE OF RANGE 22 TO THE NORTHEAST CORNER OF THE SOUTH HALF OF SECTION 13, SAID TOWNSHIP 34 NORTH, RANGE 22 WEST, THENCE WEST ALONG THE NORTH LINE OF THE SOUTH HALF OF SECTIONS 13-17 TO SAID RIVER, THENCE SOUTHERLY ALONG SAID RIVER TO THE POINT OF BEGINNING.

ALSO 5 ACRES IN THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 16 DESCRIBED AS BEGINNING AT THE SOUTHWEST CORNER OF SAID 40 ACRES; THENCE EAST 29 RODS; THENCE NORTH 28 RODS; THENCE WEST 29 RODS; THENCE SOUTH 28 RODS TO BEGINNING;
