R-II Polk County School District Proposition 1. To choose by ballot two (2) directors who shall serve as members of the Board of Education of said school district for a term of three (3) years each. (Vote for 2)	Proposition K.I.D.S. Shall the Board of Education of the Fair Play R-II School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of One Million Nine Hundred Thousand Dollars (\$1,900,000) for the purpose of providing funds to construct secure entrances, replace exterior doors, upgrade access control systems, replace heating, ventilation, and air conditioning (HVAC) systems, and upgrade lighting to LED; to replace cafeteria equipment; to replace windows, remodel restrooms, and construct covered entryways at the North and South entrances at the Elementary School; to construct a secure, enclosed walkway between the Elementary School and Middle Building; to install air conditioning in the Vo Ag Building Shop; to make improvements to the baseball and softball fields; to purchase land for additional parking; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.7385 per one hundred dollars of assessed valuation of real and personal property.
