Shall the Halfway R-III School District of Polk County, Missouri, issue its general obligation bonds in the amount of \$850,000 for the purpose of improving, renovating, repairing, furnishing and equipping school sites and buildings, including but not limited to, (1) improvements and upgrades to the plumbing and HVAC systems, (2) improvements to parking lots and (3) renovation of the gym floor?

If this proposition is approved, the adjusted debt service levy of the District is estimated to remain unchanged from the current debt service levy of \$0.7298 per one hundred dollars of assessed valuation of real and personal property.

All of the area currently being served by the Halfway Volunteer Fire Department, and specifically:

BEGINNING ON THE WEST LINE OF SECTION 17, TOWNSHIP 34 NORTH, RANGE 22 WEST OF THE FIFTH PRINCIPAL MERIDIAN IN POLK COUNTY, MISSOURI AT THE POMME DE TERRE RIVER, THENCE SOUTHERLY ALONG SAID RIVER TO THE INTERSECTION OF SAID RIVER AND THE SOUTH LINE OF THE NORTH HALF OF SECTION 36, TOWNSHIP 33 NORTH, RANGE 22 WEST, THENCE EAST ALONG SAID SOUTH LINE TO THE SOUTHEAST CORNER OF SAID NORTH HALF OF SECTION 36, THENCE NORTH ALONG THE EAST LINE OF RANGE 22 TO THE NORTHEAST CORNER OF THE SOUTH HALF OF SECTION 13, SAID TOWNSHIP 34 NORTH, RANGE 22 WEST, THENCE WEST ALONG THE NORTH LINE OF THE SOUTH HALF OF SECTIONS 13-17 TO SAID RIVER, THENCE SOUTHERLY ALONG SAID RIVER TO THE POINT OF BEGINNING.

ALSO 5 ACRES IN THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 16 DESCRIBED AS BEGINNING AT THE SOUTHWEST CORNER OF SAID 40 ACRES; THENCE EAST 29 RODS; THENCE NORTH 28 RODS; THENCE WEST 29 RODS; THENCE SOUTH 28 RODS TO BEGINNING;

ALSO 7 AND 1/2 ACRES IN THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 16 DESCRIBED AS BEGINNING 330 YARDS WEST OF THE SOUTHEAST CORNER OF SAID 40 ACRES; THENCE NORTH 110 YARDS; THENCE EAST 330 YARDS; THENCE SOUTH 110 YARDS; THENCE WEST 330 YARDS TO THE PLACE OF BEGINNING.

ALSO ALL OF SECTIONS 10-17, 19-36, ALL OF SECTION 9 LESS THE NORTH HALF OF THE NORTHWEST QUARTER, ALL OF SECTION 8 LESS THE NORTHWEST QUARTER OF THE NORTH HALF OF THE NORTHEAST QUARTER, ALL OF THE SOUTH HALF OF SECTION 18 ALL IN TOWNSHIP 34 NORTH, RANGE 21 WEST OF THE FIFTH PRINCIPAL MERIDIAN IN POLK COUNTY, MISSOURI.

ALSO ALL OF SECTIONS 3-10, 16-21, 28-30, AND THE NORTH HALF OF SECTIONS 31-33 ALL IN TOWNSHIP 33 NORTH, RANGE 21 WEST OF THE FIFTH PRINCIPAL MERIDIAN IN POLK COUNTY, MISSOURI.
